Pursuant to Article 48, paragraph 2 of the Law on the National Bank of the Republic of Macedonia ("Official Gazette of the Republic of Macedonia" No. 158/2010), Article 49 paragraph 1 of the Statute of the National Bank of the Republic of Macedonia St. No. 02/-15/IV -1/2011 from 21 April 2011 and Article 9-a paragraph 2 of the Law on performing fast money transfer services ("Official Gazette of the Republic of Macedonia" No. 77/03, 54/07, 48/10, 67/10, 17/11 and 135/11), the Governor of the National Bank of the Republic of Macedonia adopted the following

Article 1

This Rulebook shall prescribe the form and content of the Form of the application due to non-issuing permit or approval, i.e. non-adopting a decision to refuse the application for issuing permit or approval to perform fast money transfer services within the period laid down in Article 9, paragraph 1 of the Law on performing fast money transfer services.

Article 2

The application from Article 1 of this Rulebook shall be submitted to the Governor of the National Bank of the Republic of Macedonia on the Form: "Application due to non-issuing permit or approval, i.e. non-adopting a decision to refuse the application for issuing permit or approval to perform fast money transfer services" in white A4 format, which is enclosed and is an integral part of this Rulebook.

The Form under paragraph (1) of this Article shall contain: the name of the authority to which the application is submitted, space for the number and date of the application, in the middle of the application the title of the application, the name of the legal entity - the applicant, a brief description of the reasons for the application and signature of the applicant.

Article 3

This Rulebook shall enter into force on the eighth day following that of its publication in the "Official Gazette of the Republic of Macedonia".
