



NATIONAL BANK OF THE REPUBLIC OF MACEDONIA

Pursuant to Article 5 item 5 of the Law on Payment Operations ("Official Gazette of the Republic of Macedonia" no. 32/01) and Article 63 paragraph 1 item 30 of the Law on the National Bank of the Republic of Macedonia ("Official Gazette of the Republic of Macedonia" no. 29/96 and 37/98) and item 4 of the Decision on setting a standard for constructing the accounts of the participants in the payment operations ("Official Gazette of the Republic of Macedonia" no. 41/01), the National Bank of the Republic of Macedonia Council, at its LXXXVIII session, held on May 21, 2001, adopted the following

DECISION

on conferring a sorting code of the institutions responsible for conducting payment operations ("Official Gazette of the R. M" no. 41/01)
