



НАРОДНА БАНКА НА РЕПУБЛИКА СЕВЕРНА МАКЕДОНИЈА

Pursuant to Article 25 paragraphs 1 and 3 and 47 paragraph 1 item 20 of the Law on the National Bank of the Republic of Macedonia (Official Gazette of the Republic of Macedonia No. 158/10, 123/12, 43/14, 153/15, 6/16 and 83/18), the National Bank of the Republic of North Macedonia Council adopted the following

DECISION ON ISSUING BANKNOTES IN DENOMINATION OF 2000 DENARS WITH MODIFIED FEATURES

1. This Decision shall issue banknotes in denomination of 2000 denars with modified features.

2. Banknotes in denomination of 2000 denars have the main features described in the Decision on issuing and main features of banknotes in denominations of 200 and 2000 denars (Official Gazette of the Republic of Macedonia No. 74/15), with the following modifications:

- In the Decision on issuing and main features of banknotes in denominations of 200 and 2000 denars (Official Gazette of the Republic of Macedonia No. 74/15), in item 2 paragraph 1, the abbreviation: "НБРМ" (NBRM) shall be replaced by the abbreviation: "НБРСМ" (NBRNM).

- In item 3 sub-item 3.2. paragraph 1, the words: "Република Македонија" (Republic of Macedonia) shall be replaced by the words: "Република Северна Македонија" (Republic of North Macedonia).

- In paragraph 4, the abbreviation: "НБРМ" (NBRM) shall be replaced by the abbreviation: "НБРСМ" (NBRNM).

- In paragraph 8, the abbreviation: "НБРМ" (NBRM) shall be replaced by the abbreviation: "НБРСМ" (NBRNM).

- In paragraph 11, the words: "Народна банка на Република Македонија" (National Bank of the Republic of Macedonia) shall be replaced by the words: "Народна банка на Република Северна Македонија" (National Bank of the Republic of North Macedonia).

- In paragraph 16 the abbreviation "НБРМ" (NBRM) shall be replaced by the abbreviation: "НБРСМ" (NBRNM).

- In paragraph 18, the words: "the Republic of Macedonia" shall be replaced by the words: "the Republic of North Macedonia".

- In paragraph 19, the words: "Народна банка на Република Македонија" (National Bank of the Republic of Macedonia) shall be replaced by the words: "Народна банка на Република Северна Македонија" (National Bank of the Republic of North Macedonia).

- In paragraph 23, the abbreviation: "НБРМ" (NBRM) shall be replaced by the abbreviation: "НБРСМ" (NBRNM).

3. This Decision shall enter into force on the eighth day from the day of its publication in the Official Gazette of the Republic of North Macedonia.
